## J24 Gosford Classic Regatta 2016 NOTICE OF RACE

The Organising Authority for this Series is the Gosford Sailing Club.

#### 1 RULES

All races will be conducted under the following:

- 1.1 The current Racing Rules of Sailing (RRS) of the International Sailing Federation (ISAF).
- 1.2 The Prescriptions and Special Regulations of Yachting Australia.
- 1.3 The current International J24 Class Rules (except as altered by the Sailing Instructions or this Notice of Race).
- 1.4 This Notice of Race.
- 1.5 The Sailing Instructions to be issued prior to the race.

### 2 ALTERATIONS OF CLASS RULES

The curent Rules of the International J24 Class are changed as follows:

- 2.1 Where a boat deviates from the rules of measurement on hull and rigging, such deviation may be considered legal when a class measurer is satisfied that the item in question is 'as supplied by the licensed builder at the time of manufacture'. The measurement certificate shall be endorsed appropriately by the class measurer.
- 2.2 Class rule 5.3 is changed as follows: A boat may sail with different crew on different days provided the crew changes are declared at registration. The number of declared crew shall remain the same throughout the regatta. Crew changes not declared at registration require advance written approval of the Race Committee and will only be approved in exceptional circumstances.

#### 3 ADVERTISING

- 3.1 For the purpose of advertising, the classification of this championship shall be in accordance with ISAF Regulation 20.
- 3.2 Boats may be required to display advertising material chosen and supplied by the organizing authority.

### 4 ELIGIBILITY AND ENTRY

The Championship is open to boats of the International J24 Class that fulfil the following requirements:

- 4.1 Each helmsperson and crew shall be a member of a Club affiliated with their respective State or National Yachting Association. YNSW Crew Club is an affiliated club (RRS 56).
- 4.2 Each helmsperson and crew shall be a financial member of their State J24 Class Association.

- 4.3 The owner of the J24 as shown on the measurement certificate shall be a member of their State Class Association.
- 4.4 The helmspersons nominated on the 'Entry Form' will be deemed to be in charge of the boat and no change of helmsperson shall be made without the written consent of the Race Committee.
- 4.5 Each boat shall hold and lodge with the Organising Authority a current Measurement Certificate, a current Compliance Certificate issued and validated by the State Measurer and a current Inventory of Required and Optional Equipment for the International J24 Class. These forms are available on the J24 website.
- 4.6 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10,000,000 per event. A copy of the certificate of currency or policy document shall be lodged with the Organizing Authority at the time of entry.
- 4.7 Each boat shall hold and lodge with the Organising Authority a current valid Yachting Australia Special Regulations Compliance Certificate, minimum of Category 7.
- 4.8 Eligible boats may enter by completing the attached form and sending it, together with the required fee, to the Organising Authority prior to 1700hrs on Wednesday 30 September 2016.

#### 5 FEES

5.1 Non-refundable entry fee is \$150 (inc. GST), payable to Gosford Sailing Club.

#### **6 SCHEDULE OF EVENTS**

- 6.1 Six (6) races are scheduled over two (2) days of racing.
- 6.2 A maximum of three (3) races may be sailed on one day.
- 6.3 No warning signal will be made after 1430hrs on Sunday 2 October 2016.
- 6.4 While it is the intention of the Race Committee to conduct races as shown above, the Race Committee may alter the schedule and number of races. Any change to the schedule of races will be posted by 1030 hours on the day it will take effect
- 6.5 In the event of a re-sail, the date and time will be determined by the Race Committee.

#### 7 REGISTRATION & MEASUREMENT

- 7.1 Registration will be conducted at GSC race office on the nominated days.
- 7.2 The Organizing Authority or J24 National Association representative may conduct measurement & inventory checks of competing yachts at anytime, before, during and after racing.
- 7.3 Each yacht shall have all sails available for inspection and possible measurement if requested by the Race Committee.
- 7.4 Each Crew shall register and prove their J24 Membership at registration. Non members can join at Registration. All crew must register prior to 1000hrs Saturday 1 October 2016. Failure to do so shall invalidate the entry.

#### 8 SAILING INSTRUCTIONS

8.1 Sailing Instructions will be available upon registration at the GSC and will be available online on the National J24 website prior to the event.

#### 9 RACING AREA

9.1 The races will be conducted on Brisbane Waters.

#### 10 COURSES

10.1 All courses will be Windward/Leeward. Courses will be as described in the Sailing Instructions.

### 11 PENALTY SYSTEMS

11.1. The Scoring Penalty, rule 44.2 shall apply.

#### 12 SCORING

- 12.1. Six (6) races are scheduled of which Three (3) completed races are required to constitute the series. Each boat's series score will be the total of her race scores with one drop allowed.
- 12.2 Performance Handicap System (PHS) results will be decided by application of the Time Correction Factor (TCF). The PHS TCF allocated by the Race Committee, will be re-calculated between races and will not be subject to redress. This changes rule RRS 62.1(a).

## 13 HAUL OUT RESTRICTIONS

- 13.1 Boats shall remain in the water from 1000hrs on Saturday 1 October 2016 until completion of racing. Rudders shall remain affixed to the boat in their normal position during this time.
- 13.2 The Race Committee may approve a written request for a boat to be hauled out at any time provided it is satisfied that this is required for essential repairs. When haul out is approved no other work shall be done other than work that could not have been done while afloat.

## 14 PLASTIC POOLS AND DIVING EQUIPMENT

14.1 Underwater breathing apparatus, closed plastic pools or their equivalent shall not be used around boats after 1000hrs on Saturday 1 October 2016 until the completion of racing.

### 15 RADIO COMMUNICATIONS

15.1 In accordance with rule 41, the Race Committee may broadcast the course to be sailed, names/sail numbers of OCS boats, and/or any other information of interest to competitors. Any failure of, or defect in, such a broadcast will not be grounds for redress. For this purpose boats may carry a handheld VHF radio. Boats may transmit on VHF radio to communicate in the event of an emergency, upon retiring from a race or at the request of the Race Committee.

#### 16 DISCLAIMER OF LIABILITY & RISK WARNING

- 16.1 It is the competitor's decision to enter the Event or to start and continue in any race. Competitors shall accept that their participation in the Event is at their exclusive risk in every respect. By way of entry in the Event competitors must indemnify the Organising Authority their officers, members, staff and agents in respect to all claims and demands of whatever nature which may be made upon them in connection with or howsoever arising from their participation or intended participation in the Event.
- 16.2 This RISK WARNING is issued jointly by Gosford Sailing Club and NSW Maritime, pursuant to the Civil Liability Act 2002 to all persons wishing to participate in the sailing activities conducted by Gosford Sailing Club.

Participants are warned that, regardless of the precautions, which might be taken by reasonable and experienced persons, sailing can be a dangerous pursuit and participants are exposed to significant risk of property damage, physical harm and possibly death.

As an indication, these risks may include, but are not limited to:

- The extremes of weather and sea conditions.
- The potential that control of vessels may be lost, resulting in collision with objects and other vessels.
- The sudden movement of the vessel at any time and the possibility that participants may fall or be thrown overboard, resulting in drowning.
- The possibility that participants may be injured by equipment on the vessel.
- The absence of immediate medical care and the likelihood that significant delays may occur before medical care is available.
- Exposure to the elements for extended periods.

Gosford Sailing Club and NSW Maritime also warn participants that regardless of their best intentions, they may be unable to render assistance to participants who are in distress. Participants are warned to consider the above risks and all other risks before deciding to participate in any sailing event with Gosford Sailing Club.

Participants are also advised that although Gosford Sailing Club is covered by third party liability insurance, this cover DOES NOT extend to participants. Any participant who considers they have a need for insurance must make their own private arrangements with an insurer. Membership of a sailing club affiliated with Yachting NSW entitles you to personal accident insurance cover.

#### 17 INSURANCE

- 17.1 Participants are advised that GSC's third party liability insurance cover does not extend to participants. Participants must make their own private arrangements with an insurer.
- 17.2 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10,000,000.
- 17.3 Attention is drawn to the Yachting NSW insurance program at www.ynswinsurance.com, through which a proportion of insurance premiums paid by members is rebated to GSC.

#### 18 PRIZES

18.1 Prizes will be awarded to boats placed first to third overall and first to third on PHS handicap.

## 19 CRANE, TRAILER STORAGE & YACHT BERTHS

- 19.2 GSC will provide berths for all competing yachts from 31 September 2 October 2016.
